

Account Number. This is the **FIRST 4 DIGITS** found on your bill.

Tenant Number	Ex: 98

2.) Next you are asked to enter the **Tenant Number**. This is the **LAST 2 DIGITS** after the -.00 (usually a 99, 98, 97).

A Special Display to Honor Veterans

The Town of Hartland is pleased to announce the acquisition of a Vietnam Era helicopter through the U.S. Army donation program.

The Town has been on a waiting list for several years in the hopes for acquiring a piece of military equipment for display in the Town. When the call came in that the helicopter was available, we had only two weeks to accept it or get moved to the bottom of the waiting list for another piece of equipment.

The Town is working with a Volunteer Citizens Committee that has been formed with local Veterans and Gasport American Legion Post members to create a fitting and safe display to honor our veterans and current armed forces members. The helicopter was previously in the Town of DeRuyter, NY under the American Legion Woodford-Burdick Post.

WINTER WEATHER REMINDERS

Garbage & Recycle Cart Placement Guidelines

As you place your garbage and recycling carts at the roadside every Monday. please remember that it's winter time and the snowplow needs lots of room to clear your road! The typical plow truck takes up the entire width of the driving lane – from the centerline to the white edge line – and then the plow wing extends about 6 more feet across the road shoulder. While we realize that Modern Disposal asks that carts be placed "within 5 feet of the roadside," it is best during the winter months to place them 5 feet from the pavement edge or line the carts up even with the front of your mailbox. Please do not place them on the white line or close to the driving lane.

Please remove empty carts the same day after pickup!



DON'T Crowd the Plow!

Please slow down and move over when you see a plow coming toward you!

Winter Parking Regulations No Overnight Parking

Town Code prohibits parking on roadsides from November 1 through April 1 from 2 a.m. until 7 a.m. and any other time when it would hinder snow removal operations. A violation may result in traffic tickets, fines and/or towing at the owner's expense. The complete text of the law is available for review in the Town Clerk's office.

Snow Clearing

Pushing snow into and across the right of way is illegal. If the snow in the right of way causes an accident, you are liable.

Your insurance company most likely will not cover any damages or injuries and you will be personally responsible.

Mailboxes Damaged During Snow Removal

During the winter months the Highway Department will occasionally receive calls regarding damage to mailboxes, either from snow plows directly or from the force of snow being thrown by the plows.

Remember, snowplows can hurl hundreds of pounds of snow in one pass! If damage is indeed caused by snow removal, it is not done intentionally, but is an unfortunate consequence of snow removal.



In the event that a box or post is actually hit by a plow blade, we will repair or replace

it with a standard metal box. The town will not replace any fancy mailboxes, posts or paper boxes of any kind. If the force of the snow off the plow knocks the box from the post, we will re-attach it if possible. If not, we will, as a courtesy, place a temporary portable box so the resident can receive mail. It is the owner's responsibility to repair or replace their mailbox and post. When done, you may call the Highway Department to have the temporary box picked up.

If you have a decorative, expensive, or otherwise extraordinary mailbox, please consider removing it during the winter months and temporarily using a simple metal box mounted directly on top of a treated 4 x 4 post.
